*As part of our Summer Opportunities, transportation is available for **session # 1 only**. Students will be transported from home to their zoned high school and then shuttled to La Plata high school for the session one class.

Cost:

The cost of the week long prep class is \$50. In addition to twenty hours of instruction, each student will receive an SAT Study Guide to continue to practice after the class ends.
