County hosts annual Leadership Institute

Charles County Public Schools hosted its eighth annual Leadership Institute June 25-29 at North Point High School. The institute focuses on leadership skills, and vice-principals, administrators, classroom and resource teachers are invited to attend.

More than 40 CCPS employees attended the institute that was broken down into two sessions: one session for aspiring principals and another session for aspiring

leaders. Both sessions included five areas of focus, ranging from vision, instruction and accountability to communication and understanding roles, and group dynamics.

Keynote speakers were invited to speak to attendees about leadership qualities. Superintendent of Schools James E. Richmond and Carol Leveillee, principal of Mary H. Matula Elementary School, spoke to aspiring principals about educa-

tional visions and team work.

CCPS also hosted an Aspiring Leadership Conference for classified employees, such as building and food service workers, and secretaries, on June 19 at North Point.
