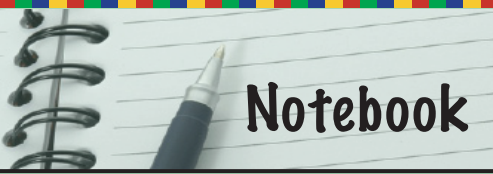

## Summer hours reminder

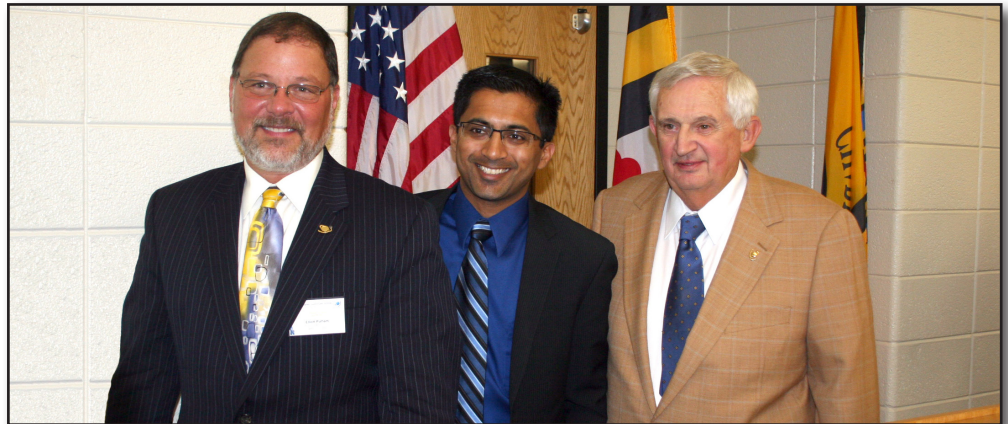
The summer hour schedule of 7:30 a.m. to 3:30 p.m. ends for schools and centers on Monday, Aug. 22.

## Educational Exchange features Director of Space Policy

The question of the day on July 26 for Chirag Parikh, director of space policy for the National Security Council, was "What does the future hold for space exploration?" Parikh was the featured speaker at the Charles County Public Schools Educational Exchange held at North Point High School. More than 100 students, teachers, school administrators and community members were invited to attend the event, which serves to educate the community on efforts the school system is making in science, technology, engineering and mathematics (STEM) education.

Superintendent of Schools James E. Richmond welcomed guests and emphasized the importance of integrating STEM education into programs for students in grades prekindergarten through 12. "Our goal is to infuse science, technology and mathematics into programs for students of all ages and at all grade levels. We are focused on providing students with the skills necessary to advance in the future," Richmond said.

Parikh, who is responsible for reviewing and writing White House space policies, talked about the impact environmental surroundings have on children and their learning styles. "Kids are influenced by their environments. In policy discussions, we talk about space STEM policies and the importance to use data that supports the focus," he said.

Parikh also talked about the next phase of the space exploration program, which he described as the second major shift in U.S. space program history. He described the Apollo program and the shift to the space program, and a new focus on trying to send humans to places in space such as Mars and the Moon. "We are working on the next generation of space technology and transportation," he added.

In addition to hearing Parikh speak, attendees participated in a question and answer session. Mattawoman Middle School student Aaron Green asked Parikh if there were plans to change the design of vehicles used in space. Parikh said there are plans to incorporate existing spacecraft designs into future vehicles with upgraded technology.

John Hanson Middle School special education teacher Sharon Mudd asked Parikh if he thought the space program is the next technology to fuel the economy and the next "way of life." Although Parikh acknowledged the importance of space technology on future generations, he said he is not sure if the program will be the next focus to help shift the economy.

The exchange, the fifth hosted by the school system, was held in partnership with the National Space Foundation and in conjunction with the Space Discovery Institute offered to county teachers.
