## Students learn locally grown food can be sweet

Using fresh fruit, a giant ear of corn and music, students at Mt. Hope/Nanjemoy recently learned a little more about where their food comes from through the Maryland Farm-to-School program.

Mt. Hope is the first school in Charles County to participate in Maryland's new program that includes using locally grown products in school lunches during Home-grown School Lunch Week, Sept. 12-16. Principal Kristen Shields said the participation is a continuation of the school's effort

to promote healthy lifestyles for students, and was the largest and most involved.

The scent of fresh cantaloupe, tomatoes and nectarines wafted through the school cafeteria on Sept. 15 as the school hosted a mini farmers' market for students. Students were able to touch, taste and feel fresh fruit at different tables. At one table, students could feel and smell different kinds of fruit, and learned about the benefits of being and eating healthy. Another table displayed fruits and vegetables in different colors and textures, and a reading table had food-based books for the students to read.

The last table was a student favorite. Bins of nectarines, tomatoes and cantaloupe were available for the children to sample. All of the healthy treats came from local farms.

## Health department, schools work to fend off flu

Flu season is approaching, and school nurses are reminding parents that flu vaccinations are recommended for all children ages six months to 18 years. The Charles County Department of Health and Charles County Public Schools are offering the seasonal flu vaccine, in the form of nasal spray,

to students in prekindergarten through fifth grade.

Elementary schools plan to send information about the vaccine to parents the week of Oct. 3. Participation is voluntary and free, and health department nurses will administer the vaccine.

## CCPS employees named top 2010 United Way donor

Charles County Public Schools (CCPS) employees were recently named the top 2010 campaign donors to the United Way of Charles County. School system employees pledged more than \$93,400 to the 2010 campaign, and has been the top campaign contributor for at least the past five years.

Dorothy L. Harper, president and CEO of the local United Way, said, "The best campaigns always have the support from their CEO's and the school system is a great example of that. We appreciate the fact that Mr. James Richmond supports United Way and encourages staff members to do the same."

Contributions to United Way support a number of Charles County agencies, many of which are child oriented and assist special populations.

Several schools were recognized on Sept. 14 for an increase in donor participation and funds raised. William A. Diggs Elementary School, Theodore G. Davis Middle School and Westlake High School were honored for having the largest amount of monetary increases from 2009 to 2010. Davis, C. Paul Barnhart Elementary School and Henry E. Lackey High School were

recognized for having the highest increase of donor participation in 2010.

Additionally, Barnhart, Davis and Indian Head Elementary School were acknowledged for experiencing the greatest percentage increase of donations among schools in the county from the 2009 campaign to the 2010 campaign.

"School system employees continue to show support for our community and help those in need. I am pleased to work with those who give back to the community by volunteering or making monetary donations in order to make Charles County a better place to live," Superintendent James E. Richmond said.

"Charles County Public Schools support to the United Way is unique. You don't see this level of help in other places," Harper said.

The United Way's 2011 campaign officially began last month and individual schools will kick off their campaigns in October. Charles County Public Schools provides employees opportunities to support the campaign through payroll deduction and direct donations.

Volunteers, like Annie Boyden, helped at the event. Boyden, mother of prekindergarten and third-grade students, said she likes to volunteer whenever she can. "I like being involved with my children's school. I know my children like when I come to help out and I love showing my support."

Susan McQuilkin and Christine Bergmark, program spokeswomen, explained to the students about the benefits of a healthy diet and lifestyle. They, along with their friend Cornelia, a life-size cornhusk character created by students in Southern Maryland, had the children use their five senses to learn about different fruits.

The program, which is implemented on

a state level, aims to bring more Maryland-grown products to school lunch rooms and to help educate students about where their food comes from, how it is produced, and the benefits of a healthy diet. According to the National Farm to School Network, Maryland is the only state where all of the public school systems participate. The Farm-to-School Program, is sponsored by the Maryland Department of Agriculture and the Maryland State Department of Education.

## Charles County Public Schools provides new Employee Assistance Program

Charles County Public Schools (CCPS) has a new Employee Assistance Program (EAP) provider. GHE HealthCare (GHE), a national provider of employee assistance programs, has been contracted by CCPS to offer services for employees.

### What is an EAP?

The EAP is a benefit offered to CCPS employees to help with personal problems that may be upsetting your life, job or family. The program provides help for personal, emotional or family problems as well as alcohol or drug-related, job stress or other mental health issues. The EAP helps decrease absenteeism due to stress and personal problems.

### What is offered?

The assessment, evaluation and initial consult with an EAP counselor are free, along with short-term counseling. Further counseling after the initial service is usually covered by insurance. All use of the assistance is confidential. Charles County Public Schools assumes the cost for the initial EAP assessment. If additional services are needed, an appropriate referral is made.

### Who is eligible?

This service is available to all employees who work 20 hours or more per week and their immediate family members.

### Is it confidential?

Confidentiality is maintained. If you contact the Employee Assistance Program directly, no one in the system will know. No information concerning the nature of your problem is released without written consent.

### What is GHE HealthCare?

GHE HealthCare is a national provider of EAP and specializes in helping employees with issues affecting their lives and jobs. GHE offers local counselors who specialize in EAP issues. They are licensed psychologists and counselors.

### Why did the school system change providers?

Administrators are always reviewing benefit offerings and ensuring that the school system is offering the highest quality programs at the best available cost. A formal request for proposal was conducted in June and a committee, composed of administrators and employee representatives, evaluated and selected GHE.

### How do I use GHE?

To use GHE, an employee can call toll free at 866-443-3277, 24 hours a day, seven days a week. Supply your Zip Code and name and phone number. A GHE counselor will then schedule a mutually convenient appointment with an employee.

## Nominate an outstanding principal for the Post leadership award

Charles County Public Schools (CCPS) is accepting nominations for its 2012 Principal of the Year and the *Washington Post* Distinguished Educational Leadership Award (DELA). The annual award honors exemplary principals and recognizes those who go beyond the day-to-day demands of their position to create an exceptional educational environment.

Teachers, students, former students, parents, administrators or community members may submit nominations. Nominees must have a minimum of five year's experience as a principal and three of those years must have been with Charles County Public Schools. Principals may not nominate themselves.

Nomination materials must include a minimum of four statements of support, one of which must be submitted by a professional educator; a brief career summary; and a description of contributions in each of the nomination criteria categories.

The nomination criteria for principals are

- manage effectively;
- demonstrate and encourage creativity and innovation;
- foster cooperation between the school and the community;

- maintain a continuing dialogue with students and parents as well as faculty and staff;
- keep abreast of developments in the field of education;
- encourage team spirit;
- demonstrate leadership and exemplify commitment;
- continue to play an active role in the classroom;
- maintain their position as principal throughout the 2012-13 school year; and
- attend the four day DELA seminar to be held July 12-15, 2012.

Nominees must also serve in schools that have made Adequate Yearly Progress (AYP) for the past two school years.

Charles County's 2012 Principal of the Year will be one of 21 recognized by the *Post* from the District of Columbia, Maryland and Virginia.
